

# A BRIEF HISTORY OF THE U.S.S. HABERSHAM (AK-186): -

The keel for the motor vessel HABERSHAM (Hull #MC-2117) was laid on 28 December 1943 at Walter Butler Shipbuilders Inc., Superior, Wisconsin, for the account of the U.S. Maritime Commission. The vessel was launched 7 June 1944, and building was completed 17 November 1944. The vessel was then ferried to Beaumont, Texas for re-assembly and fitting out, arriving 5 February 1945. On April 26, 1945 the vessel was accepted by the U.S. Navy. The U.S.S. HABERSHAM (AK-186) was placed in commission at Houston, Texas on 12 May 1945. Lieutenant Commander Malcolm A. Mac PHEE, (DM), (13689), U.S. Naval Reserve, Commanding. During the forthcoming few weeks the vessel was attached to the Industrial Manager, Eighth Naval District and on 21 May 1945 reported to Commander Gulf Shakedown Group, Galveston, Texas for shakedown training. During this period of time miscellanious drills, exercises and pre-shakedown and shakedown requisites were accomplished. Shakedown training was completed in the Galveston Area on 27 May 1945, at which time the ship entered the Texas coast Shipyards for a five day post shakedown availability. On 2 June 1945 the vessel was released by the Commander Gulf Shakedown Group to the Chief of Naval Operations for routing to Commander Service Force, Pacific Fleet, with ultimate assignment to Commander Service Squadron Eight, Service Force, Pacific Fleet, and on this date she proceeded to Gulfport, Mississippi to load general and refrigerated cargo. Upon completion of loading operations on 6 June the vessel departed the U.S. for Pearl Harbor, T.H., via the Panama Canal. Date of arrival at Panama, Canal Zone was 12 June 1945 and date of departure from Balboa, Canal Zone was 13 June 1945. On 13 June 1945 ship was reported by dispatch to Commander Service Squadron Eight, Service Force, Pacific Fleet, for duty. The ship arrived at Pearl Harbor, T.H. on 30 June 1945. All cargo was discharged at Pearl Harbor and on 4 July 1945 the ship proceeded to San Francisco, California with passengers, general cargo and U.S. Mail. Arrival at San Francisco, was on 12 July 1945. On 17 July loading operations were commenced, with the cargo being general and refrigerated. On 21 July loading operations completed and vessel took departure for Eniwetok, Marshall Islands. Arrival at Eniwetok, Marshall Islands was on 7 August 1945 and unloading operations commenced this date. Orders were received on 27 August 1945 from Commander in Chief, Pacific Ocean Area, Pearl Harbor, assigning this vessel temporary operational control of Commander Service Division 102. During the period of arrival until 9 September 1945 cargo was discharged and loaded at various times. On 9 September 1945 vessel took departure from Eniwetok, Marshall Islands enroute to Tokyo Bay, Japan, steaming in compnay with task unit 30.9.23, Commander Task Unit in this vessel. Date of arrival at Tokyo Bay, Japan was 17 September 1945.
