
Attorney General Sees **Every Reason to** Approve.

Decision Gives Light Upon Status of Holdings-All Ready for Action by Congress.

(Mail Special to the Advertiser.) WASHINGTON, D. C., March 28 .-Assistant Secretary Taylor, at the Treasury Department, said today that a legal report had been received from the Attorney General, stating that the proposed transfer of public lands in Hawall for what is known as the Bishop street site, to be used as a site for the new postoffice building, was entirely legal and regular.

It appears that Governor Dole, some time in January, addressed a letter to the Secretary of the Interior notifying him of the acquisition of a site for a public building-the arrangement being subject to the acceptance by the Secretary of the Treasury of the site for federal building purposes. The opinion of the Attorney General was requested as to the power of the Territorial officers to acquire a site in this manner, and also as to the power of the Treasury Department to assume
