

Commissioning of a Navy Ship

The commissioning ceremony marks the acceptance of a ship as a member of the operating forces of the United States Navy. At the moment of breaking the commissioning pennant, USS BATON ROUGE (SSN 689) becomes an active member of the fleet. The Commanding Officer, together with the ship's officers and men, has the duty of making and keeping her ready for any commitment required by our nation in peace or war.

The commissioning pennant is the historic symbol of a man of war. It is believed to date from the 17th century when the Dutch Admiral Maarten Van Tromp hoisted a broom at his masthead to symbolize his having swept the British from the sea at Dungeness. The following year, British Admiral William Blake hoisted a horse whip to his masthead—indicating his intention to chastise the Dutch. The victorious British thus set the precedent for a long, narrow commissioning pennant as a symbol of Admiral Blake's horse whip and as the distinctive mark of a ship of war.

She returned to Newport News Shipbuilding for the next milestone in the ship's history on April 26, 1975. With a mighty swing of a champagne bottle, and the proud words "I Christen Thee BATON ROUGE," she launched the ship on its journey to the sea.

Mrs. Hébert, the former Gladys Bofill, is the wife of the Honorable F. Edward Hébert, the distinguished United States Representative from the First District of Louisiana, and former Chairman of the House Armed Services Committee.

The Héberts have one daughter, Dawn Marie (Mrs. John M. Duhe, Jr.), residing in New Iberia, Louisiana, and four grandchildren.





Assistant Secretary of the Navy The Honorable Edward Hidalgo

On April 1, 1977, President Jimmy Carter nominated Edward Hidalgo to be Assistant Secretary of the Navy (Manpower, Reserve Affairs and Logistics). He was confirmed by the Senate and took the oath of office on April 25, 1977.

Secretary Hidalgo was born in Mexico City, Mexico on October 12, 1912. He has been a resident of the United States since early childhood. He received a B.A., Magna Cum Laude, from Holy Cross College in 1933 and a J.D. from Columbia Law School in 1936. In 1959 he received a Degree in Civil Law from the University of Mexico. He served as a Lieutenant in the U.S. Naval Reserve from 1942 to 1946.

From 1943 to 1945 he served as an air combat intelligence officer on the carrier Enterprise, and he was a member of the Eberstadt Committee which reported to the Secretary of the Navy on Unification of the Military Services in 1945. He received the Bronze Star for his services aboard the Enterprise and a Commendation Ribbon for his service with the Eberstadt Committee. In 1945 and 1946 he served as Special Assistant to the Secretary of the Navy, James Forrestal.

From 1965 to 1966, Mr. Hidalgo was Special Assistant to the Secretary of the Navy, Paul H. Nitze, and from 1966 to 1972, he was a partner in the law firm of Cahill, Gordon & Reindel, in charge of their European office. In 1972 he served as Special Assistant for Economic Affairs to the Director of the U.S. Information Agency and in 1973 he became General Counsel and Congressional Liaison of the Agency.

Secretary Hidalgo is married to Karen Dane Jernstedt and has four children. They reside at 2435 California Street, N.W., Washington, D.C.

Vice Admiral Pierre N. Charbonnet, Jr.

Pierre Numa Charbonnet, Jr. was born on December 22, 1919, in San Francisco, the son of Dr. Pierre N. Charbonnet of New Orleans, and Blanche Rogers Charbonnet of Tulsa, Oklahoma. He was appointed to the U.S. Naval Academy in 1937, and was commissioned ensign on February 7, 1941. He subsequently advanced in rank, attaining the grade of Vice Admiral on August 23, 1974.

During World War II, while serving as Commander of Carrier Air Group 24 aboard USS SANTEE, he was awarded the Distinguished Flying

Cross with Gold Star, and the Air Medal with six Gold Stars.

Admiral Charbonnet has been awarded the Legion of Merit three times, receiving the first for "exceptionally meritorious conduct" while engaged in coordination of all carrier combat air operations in North and South Vietnam.

Admiral Charbonnet's first assignment as a flag officer was as Commandant Eighth Naval District. He later served as Commander Carrier Striking Force Sixth Fleet, and as Director Fleet Operations Division and Director Naval Reconnaisance Center.

On April 3, 1971 Admiral Charbonnet relieved Commander Fleet Air Mediterranean/Commander Anti-Submarine Warfare Force, Sixth Fleet/Commander Maritime Air Mediterranean. He assumed duty as Chief of Naval Reserve, with headquarters in New Orleans, in August 1974.

The Admiral is married to the former Mary A. Dutton of Annapolis, Maryland. The couple has five children: Hildegarde, Louise, Michelle, Pierre N., III, and Suzanne.





Vice Admiral Kenneth M. Carr

Vice Admiral Kenneth M. Carr was born in Mayfield, Kentucky, March 17, 1925, and graduated from high school in San Bernardino, California in 1941. After attending San Bernardino Valley College for two years, VADM Carr enlisted in the Navy as a seaman.

He was a crewman on an assault landing craft attached to the USS PRESIDENT JACKSON (APA18) in late 1943, and participated in the landings at Bougainville, Solomon Islands, and the initial landing in February 1944 at Green Island, Bismarck Archipelago.

Prior to being commissioned, in 1945 he was appointed to the U.S. Naval Academy as a member of the Class of 1949. He entered Submarine School in 1950.

In 1972 Admiral Carr was assigned as Chief of Staff to the Commander Submarine Force, U.S. Atlantic Fleet. In March 1973, Admiral Carr was ordered to duty as Military Assistant to the Deputy Secretary of Defense. He assumed command as Commander Submarine Force, U.S. Atlantic Fleet on June 20, 1977.

Admiral Carr's decorations include: Legion of Merit, 1 Gold Star, Meritorious Service Medal; Defense Distinguished Service Medal, Presidential Unit Citation; Navy Unit Commendation; Meritorious Unit Commendation; American Campaign; Asiatic and Pacific Campaign; World War II Victory Medal; National Defense with 1 Bronze Star; Korean Service; Korean Presidential; United Nations Service.

He is married to the former Molly Pace of Burkesville, Kentucky.

The Honorable W. W. "Woody" Dumas

W. W. "Woody" Dumas was elected Mayor-President of the City of Baton Rouge and Parish of East Baton Rouge, Louisiana, November 3, 1964. He was re-elected in 1968, 1972 and again in 1976.

Mayor Dumas was reared and educated in East Baton Rouge Parish. He lettered in basketball and football during high school and later played semi-professional baseball and professional football. He served eleven years in the United States Navy, during which time he graduated from the United States Submarine School in New London, Connecticut. He served with the submarine forces in the South Pacific during World War II from 1942-1946, and also served during the Korean War. He is currently a member of the Navy League.

Mayor Dumas is the recipient of the Louisiana Municipal Association Achievement Award for accomplishments and improvements among the largest cities in the State of Louisiana.

In 1975, Mayor Dumas received the Public Affairs Award from the Louisiana Association for Mental Health for his role in establishing the Margaret Dumas Memorial mental health center in Baton Rouge.

Mayor Dumas is a member of the Board of Directors of the National Association of Counties, where he is presently serving as Chairman for the renewal of revenue sharing. In 1975, the Board appointed Mayor Dumas to serve as the National Chairman of the Athletic Foundation, U.S.A., Inc.

Mayor Dumas is married to the former Carol Epperson of Baker, Louisiana; they have two children.



City of Baton Rouge

On the present site of Louisiana's historic Old State Capital Building there once stood a tall red cypress tree, stripped of its bark, marking the boundary between the hunting grounds of the Houma and Bayou Goula Indians. French voyageurs aptly named the tree "the red stick"— le baton rouge.

Louisiana's Capital City, Baton Rouge was founded in 1719 by the French during their exploration of the Mississippi River. Since then, the flags of seven governments have flown over Baton Rouge... from the fleur-de-lis

of the Bourbons to the stars and bars of the Confederacy.

The Commanding Officer Commander Thomas Clogher Maloney

Commander Thomas C. Maloney was born on Nantucket Island, Massachusetts, the son of Mr. and Mrs. Richard C. Maloney. During his youth he lived in Virginia, Washington, Kansas, and Pennsylvania. He graduated from State College High School, State College, Pennsylvania in June 1954 and entered the U.S. Naval Academy that summer. Commander Maloney graduated with distinction from the Naval Academy in June 1958.

After graduation Commander Maloney served for a year as Fire Control Division Officer aboard USS RANDOLPH (CVA 15). He then attended the Naval Submarine School in New London, Connecticut graduating in December 1959. Commander Maloney's first submarine duty was aboard USS SAILFISH (SSR 572) where he qualified in submarines and served as Supply Officer, Gunnery Officer, Engineer Officer, and Operations Officer. In 1963 he reported to the Naval Nuclear Power School for theoretical training in nuclear engineering followed by practical training in 1964 at the Naval Nuclear Power Training Unit.

Commander Maloney was then assigned to the nuclear attack submarine USS SWORDFISH (SSN 579) where he served as Weapons Officer, Main Propulsion Assistant, Operations Officer and Navigator. In May 1968 he reported to the Precommissioning Unit of USS SPADEFISH (SSN 668) to serve as Executive Officer.

In 1971 Commander Maloney returned to Bainbridge, Maryland to command the Naval Nuclear Power School until May 1974. Following Prospective Commanding Officer training, he assumed the duties of Prospective Commanding Officer, BATON ROUGE (SSN 689) and Commanding Officer, BATON ROUGE Precommissioning Unit at Newport News Shipbuilding.

Commander Maloney is married to the former Mary Jo McAleer of Hillsdale, New Jersey. Commander and Mrs. Maloney reside in Hampton, Virginia with their children Thomas Jr., Anne, Catherine, Julia, and David.

Lieutenant Commander Galen Robert Plummer

Lieutenant Commander Galen R. Plummer was born in Milo, Maine, the son of Mr. and Mrs. Frank E. Plummer. He graduated from Robert W. Traip Academy, Kittery, Maine in June 1958. Lieutenant Commander Plummer entered Columbia University in September 1958 as an NROTC Regular Midshipman and graduated in June 1962 with a Bachelor of Arts degree. In June 1963 he graduated from Columbia School of Engineering with a Bachelor of Science degree in mechanical engineering science.

After graduation, Lieutenant Commander Plummer reported to the Naval Nuclear Power School for theoretical training in the Naval Nuclear Power Program followed by practical training at the Naval Nuclear Power Training Unit and Naval Submarine School. He reported for his first submarine duty aboard USS WAHOO (SS 565) where he served as Supply Officer and Communicator. He was then assigned to the nuclear attack submarine USS PLUNGER (SSN 595) where he served as Reactor Control Officer, Electrical Officer, Main Propulsion Assistant, and Damage Control Assistant. In March 1968 he reported to USS PATRICK HENRY (SSBN 599) Blue Crew in Holy Loch, Scotland for duty as Engineer Officer. After a three year tour he was assigned to USS GREENLING (SSN 614) and served as Navigator and Operations Officer.

Lieutenant Commander Plummer returned to the Naval Submarine School in December 1972 and served as an instructor in advanced submarine tactics. In December 1974 Lieutenant Commander Plummer reported to the Precommissioning Unit of USS BATON ROUGE (SSN 689) at Newport News Shipbuilding and assumed duties as Executive Officer.

Lieutenant Commander Plummer is married to the former Regina L. Conklin of Northport, Long Island, New York. Lieutenant Commander and Mrs. Plummer reside in Newport News, Virginia with their two children, David and Sandy.

Chief of the Boat

Master Chief Radioman (SS) James R. Olivas

A submarine's Chief of the Boat is assigned a unique combination of duties and authorities ranging from the mustering of a working party to the individual counseling he provides as the Senior Enlisted Advisor. Serving as administrative assistant to the ship's Executive Officer, the Chief of the Boat is a key element in the ship's administrative organization.

Master Chief Olivas was born in Bronte, Texas on June 17, 1935. He enlisted in the Navy in February 1959. In August 1962, Master Chief Olivas was ordered to Submarine Base New London, Connecticut for Basic Training in Submarines. Upon graduation, he was ordered to Naval Schools Command, Mare Island, California for training in cryptographic equipment.

He was ordered to U.S. Naval Training Center, Bainbridge, Maryland in April 1967 for training in advanced electronic communications systems maintenance. Upon completion of school he reported to USS CUBERA (SS 347). After a short tour in USS CUBERA, he was transferred to USS RAY (SSN 653) where he served as Chief of the Boat and Leading Radioman. In January 1973, he was transferred to Naval Communications Station, Norfolk, Virginia for a tour as Chief in Charge of Communications. Master Chief Olivas assumed the duties of Chief of the Boat BATON ROUGE (SSN 689) Precommissioning Unit at Newport News Shipbuilding in December 1974.
