At 1600, the LCM(3), while being hoisted aboard on to #3 hatch, from port side, fell from the hoisting hook onto the ship at frame #75 and from there into the water - a drop of twenty-five (25) feet. The landing craft filled with water and capsized, but was immediately secured to the ship's side and later hoisted aboard.

Five (5) men sustained injuries and were immediately given first aid by the ship's doctor. Two men were later transferred to the U.S. Naval Hospital, Long Beach, California, for x-rays and further treatment.

After thorough investigation, the cause of the accident was attributed to a faulty shackle on the slings which were furnished as original equipment on the landing craft.



At 0850, U.S.S. MOUNT HOOD (AE-11) which was anchored 2800 yards distant, bearing 180°(t), exploded and sank immediately beneath a towering column of dense black smoke which screened the entire area adjacent to her anchorage. Against the possibility that an aerial bombing was underway, all hands responded immediately to General Quarters. No material damage nor personnel casualties resulted aboard UVALDE. At 0855 UVALDE's Fire and Rescue Party joined boats of other ships present at the scene of action. At 0943 the Ship's Doctor answered a call from U.S.S. ALHENA (AKA-9) for medical assistance, blood plasma, and other medical supplies. At 1018 blood plasma and other medical supplies were dispatched to U.S.S. MINDANAO (ARG-3), and at 1052 sent a Thomas splint to U.S.S. MAULEY (APD-1)

No further description or analysis of the circumstances surrounding this catastrophe, upon which any value as an eye-witness account could be set, can be here attempted because of the split-second action and this ship's comparative remoteness from the anchorage of MOUNT HOOD. It had been known that a barge had been tied alongside the starboard side of MOUNT HOOD and that apparently, ammunition was being unloaded on to it.

UVALDE's boats remained for several hours in the vicinity to aid in the search for survivors.

11, 12 November 1944





At 2327 this date, a plain language radio despatch which is reproduced in full below reported that a merchant ship had sighted a submarine in the vicinity of this vessel. This information was coordinated with the plot then being maintained in CIC on a surface vessel. The events as recorded and plotted immediately preceding and following the receipt of the contact report are logged below.

- 2200/28 Ship in Condition II and darkened, steaming on base course 097°(t), zig-zagging according to Plan #45 of Zig-Zag Diagrams of 1940, making good 13.5 knots. Ship's position: Lat. 12° 21' 45" N, Long. 151° 37' 30" E.
- 2219/28 Surface target which was designated target "A" was picked up on the SG radar bearing 050°(t), range 34,700 yards. A DRT track was set up and the target's course and speed were determined to be 127°(t), 11 knots. Due to the range at which it was picked up, the course, speed and fact that it showed IFF, the target was evaluated as a Naval auxiliary. Due to subsequent events, it is believed at least possible that the IFF indication might have been a second sweep return from a distant ship and that the target under consideration was a merchantman, unless some merchantmen are now equipped with IFF, of which possibility we are not aware.
- 2229/28 Target "A" appeared to change course to 1010(t).
- 2250/28 Target "A" altered course radically to 3250(t) and appeared to increase speed 1 or 2 knots.
- 2302/28 Target "A" changed course to 105°(t) and continued on this course at a speed of 13 knots until 0016, when it faded from view at 44,000 yards. The action of this ship occasioned some speculation when the course change was first noticed. This maneuver carried it to a point 8,700 yards in a direction of 345°(t) from its position at the start of the maneuver, at which point it resumed a course approximately the same as the original of 127°(t).

The ship anchored temporarily in San Fernando Harbor, LINGAYEN Gulf, LUZON Island, PHILIPPINE Group at 0855, and at 0922 got underway for AGOO, LINGAYEN Gulf in obedience to visual dispatch #612353 from the Port Director, SAN FERNANDO. 1125 Anchored off AGOO, LINGAYEN Gulf.

18 October 1945

Anchored as before. 1325 Commenced loading vehicles from LCT's.

19 - 20 October 1945

Anchored as before, receiving ASCOMO vehicles and some general cargo. Six (6) officers and one-hundred thirty-three (133) enlisted men reported aboard on 20 October 1945 for transportation in accordance with Movement Order of Headquarters, ASCOMO, dated 6 September 1945.

21 October 1945

OO20 Completed loading cargo. At 0740 the ship got underway for San Fernando, LUZON Island by authority of radio dispatch #200426 of October 1945 of Commander Amphibious Group FOURTEEN. At San Fernando rendezvous was made with the U.S.S. DIPHDA (AKA-59), and Task Unit 54.15.19, consisting of the DIPHDA and this vessel, was formed with Commander H. C. WILSON on the DIPHDA as O.T.C. In obedience to sailing order dated 21 October 1945 from Port Director, LINGAYEN, reference radio dispatch #200426 of October 1945 of Commander Amphibious Group FOURTEEN, the ship was underway again at 1549 for WAKAYAMA, HONSHU Island, JAPAN, taking station 800 yards aster of the DIPHDA.

Discharging cargo as before. Three (3) officers and thirty (30) enlisted men of the 33rd Signal Construction Battalion were debarked in the morning, transportation completed.

29 October 1945

Ollo Completed unloading cargo. At 0725 the ship got underway to go alongside the U.S.S. PECOS (AO-65) in berth "B-52" for fueling. The ship moored portside to the PECOS at 0824 and at 1440 got underway for berth "B-43" in compliance with Port Director, WAKAYAMA, visual dispatch #282300 of October 1945. 1503 Anchored in berth "B-52". The remaining Army passengers aboard, four (4) officers and one-hundred three (103) enlisted men, were debarked at destination in the morning.

30-31 October 1945

Anchored as before, awaiting sailing orders. On 30 October 1945 the UVALDE was ordered to report to Commander Service Force, Pacific Fleet for duty (permanent post-war assignment) by Commander in Chief, U.S. Pacific Fleet dispatch #290320 of October 1945. The UVALDE remained at anchor on the 31st of October.

The keel was laid on 27 March 1944, as the S.S. WILD PIGEON, but the ship was taken over by the Navy. It was the first ship on the West Coast to be built from the keel up as an "AKA". She was built by the Moore Drydock Company, Oakland, California, and was launched on 20 May 1944. Commodore C.G. McCord, U.S.N., Ret., accepted the ship for use in the naval service and delivered her to the Commanding Officer, Lieutenant Commander William M. McCloy, (D), USNR, at an impressive commissioning ceremony at 1100 on 18 August 1944.

The first five days of the ship's life were spent at Naval Supply Depot, Oakland, California, where stores, provisions, fuel, and landing craft were taken aboard. During the next five days the ship was depermed, radar and radio calibrations were made and exercises were concluded by running the measured mile.

On 29 August 1944 the UVALDE proceeded from San Francisco to San Pedro, California. Upon her arrival on 31 August, Captain E.P. Abernathy, USN, accompanied by his staff, came on board and made an inspection the results of which were satisfactory.

During the period from 1 September through 13 September 1944 the ship went through extensive shakedown exercises, upon the completion of which she got underway on 14 September for San Diego, California, for amphibious training.

From 15 September through 30 September the UVALDE conducted amphibious landing exercises in company with the U.S.S. APPLING (APA-58), and on 30 September 1944 returned to Terminal Island, California, for a post-shakedown availability period of one week.

Leaving Los Angeles Harbor on 10 October 1944 the UVALDE arrived in San Francisco on 11 October. From 11 October 1944 through 19 October, she loaded cargo at Pier 90-B, Islais Creek, San Francisco.

On 20 October 1944 UVALDE was underway from San Francisco, California, enroute to Manus Island, Admiralty Islands. On 1 November 1944 she crossed the International Date Line, and on 5 November all hands turned out to welcome aboard King Neptune as the UVALDE crossed the Equator. After a 6000-mile maiden voyage, the UVALDE arrived at her destination on 6 November 1944.

The next three days were spent in awaiting orders to discharge cargo. At 0820 on 10 November 1944, the U.S.S. MOUNT HOOD (AE-11) exploded and sank immediately. Many ships in the near vicinity of the MOUNT HOOD suffered an extreme number of casualties. The UVALDE responded by sending medical assistance and supplies to all in need.

On 13 November the UVALDE received orders to proceed to East Murzim Dock to commence unloading cargo. Unloading was completed on 21 November and on the 29th the UVALDE got underway for Milne Bay, New Guinea. On 3 December 1944 the UVALDE tied up to Pier 1, Hillimoi, Milne Bay, where 100 tons of miscellaneous cargo was loaded for Headquarters 489th Port Battalion, Transportation Corps, 6th Army. On 5 December 1944 UVALDE got underway for Oro Bay, New Guinea, arriving on 6 December. From 17 December through 19 December she loaded 1,025 tons of cargo consisting of vehicles, gasoline and organizational equipment for units of the 6th Army.

On 21 December 1944, the UVALDE and the U.S.S. BLACKWOOD (DE-219) were und way from Oro Bay, New Guinea, to Manus Island, Admiralty Group, arriving there on 22 December.

On 2 January 1945 the ship was underway on her first mission of war as part of Task Group 77.9, Rear Admiral R.L. Conolly, USN, Commander Reinforcement Group. On the morning of 11 January the UVALDE entered Lingayen Gulf, Luzon, and at 0925 our first boat load of cargo had reached the beach. During her stay at Lingayen Gulf the UVALDE witnessed her first suicide attacks by the Japanese Air Corps. On 13 January 1945 she was again underway from Lingayen Gulf to Leyte, where she arrived on 16 January. Two days later UVALDE weighed anchor and got underway for Biak, in the Schouten Group, arriving there on 23 January, when loading commenced at Dock #2, Sorido Lagoon.

Having completed loading on 2 February 1945 the UVALDE got underway for Leyte. On 3 February she joined formation with Task Group 78.5, Commodore H.W. Graf, USN, C.T.G. 78.5. The UVALDE anchored in Leyte Gulf on 6 February, remaining there until 7 February when she got underway for Mindoro Island. On 9 February she arrived at her anchorage at Mindoro and twenty-seven hours later was finished unloading, receiving a "Well Done" from Captain R.W. Abbott, USN, who was then O.T.C. 12 February found the UVALDE again at Leyte making preparations for another invasion. Six weeks of practice followed, and on 27 March 1945 the ship was underway for Okinawa. She steamed into the attack area on 1 April 1945 and by noon of the same day unloading was well under way. At 0559 on 3 April 1945 the UVALDE shot down a Japanese suicide plane making a straffing attack on the U.S.S. LATIMER (APA-152). Official credit was received from C.T.D. 41 and with it, the right to display a painted Jap flag on her bridge.

During her stay from 1 April to 9 April 1945, the UVALDE was continually at General Quarters due to frequent air attacks from the enemy. On 9 April the ship was underway to Saipan, Marianas, and upon arrival there, proceeded to Pearl Harbor.

After provisioning ship and loading cargo for the Marianas, the UVALDE left Pearl Harbor on 10 May 1945, arriving at Eniwetok eight days later. After taking on and discharging cargo and passengers she got underway for Guam. When unloading was finally completed in the Marianas, the UVALDE was ordered to proceed to San Francisco. Leaving Guam on 27 June she arrived in San Francisco on 12 July 1945. On 16 July the ship departed from San Francisco enroute to Everett, Washington, arriving there on 18 July. The ship was then drydocked to obtain repairs, which were completed on 28 July 1945.

Leaving Everett, Washington on 1 August 1945, the ship proceeded to San Francisco to load and return overseas. Loading was completed on 11 August and the following day the UVALDE was underway from San Francisco enroute to Pearl Harbor. At 1400 on 14 August 1945, the President of the United States announced in a radio broadcast that a state of war no longer existed between the United States and Japan, and that the Imperial Japanese Government had surrendered unconditionally.

On 17 August the ship arrived in Pearl Harbor and the following day commenced unloading cargo at Berth K-5. Unloading was completed on 24 August and on 11 September the UVALDE proceeded to Pier 39-A, Honolylu.

On 13 September 1945 the crew mustered at quarters for Change of Command Ceremonies, and at 1330 Commander William M. McCloy, (D), USNR, relinquished command to Lieutenant Frank C. Dilworth, USN. Lieutenant Jack W. Grove, (D), USNR, assumed

, the duties of Executive Officer and Navigator.

On 14 September 1945 the UVALDE got underway from Honolulu for Guam, arriving there on 26 September. On 0700 the following day she got underway for Saipan, and arrived at that port on 1700 the same day.
