The U.S.S. Sedgwick County was constructed by Chicago Bridge and Iron Co. at Senaco, Illinois in 1945 and was commissioned as LST 1123. She served on continuous active duty until July 1955 when she was decommissioned in San Diego & maintained in the Pacific Reserve Fleet. The LST 1123 has seen much service throughout the Pacific Area. Before the Korean Conflict her duties included three trips to Alaska in 1947-48-49 for Arctic re-supply, as well as tours in the Far East.

When fighting broke out in Korea in June, 1950 she was one of the first ships to enter the combat area and participated in the amphibious assault on Inchon during September of that year. For the remainder of the hostilities she carried troops and prisoners as well as combat cargo. The largest amphibious demostration at Kojo, on Korea's East Coast, saw the 1123 as flagship for all landing ships.

A later tour in Westpac saw her participate in the large-scale movement of the Japan Ground Self-Defense Force from Shikoku in Southern Japan in Hokkaido, the northern most island. Cheering throngs greeted the ship in every port, and each arrival was made the occasion for speeches and parties, all emphasizing Japanese-American friendship. While off the harbor of Otaru, in northern Hokkaido, the ship rode out the great typhoon of September, 1954 which capsized several large ferry boats in that vicinity. The 1123 proceeded to the scene of the disaster to rescue survivors.

With her return to active duty the Sedgwick County will become a unit of Landing ship Squadron Three with her home port in Guam.

THE NAME

On 12 May 1955 U.S.S. LST 1123 was redesignated USS SEDGWICK COUNTY (LST-1123) in Honor of Sedgwick County, Colorado. Sedgwick County, Colorado adjacent to Julesburg, Colorado, the County Seat of Sedgwick County. This area is rich in the history of the old west; when the pony express was started in 1860 with Julesburg as the only Colorado station, Buffalo Bill was hired there as the youngest rider. Later he served at Fort Sedgwick as scout and guide. Fort Sedgwick was named for General John Sedgwick, a Union Army Commander, who was killed at the Battle of Spottsylvania in May, 1864.
