6 June 1944.

1. ICT 647 loaded at Portland Harbor and proceeded in convoy with the ships of Force 0-3. Arrived at Omaha rendezvous area number three at 0700 D-day. Left for line of departure at 0810 in company with ICT 648 and ICT 415. Arrived at line of departure at 0945 and was ordered to stand by because of the crowded condition of the beach and heavy enemy fire. Ordered into the beach at 1730. Beached and unloaded 13 vehicles, two vehicles were drowned-out. Retracted from the beach at 1733 and proceeded to rendezvous area number three for further assignment. ICT 647 sustained no damage or casaulties to personnel due to D-day operations.
